Important information about applying grants to the Foundation for Cross Cultural Understanding:

Purpose of Sub Funds

Grants can only be approved when the project/activity is in line with the sub-funds purpose

- A. Sarah Ernst Darnall Fund, to support the educational and cultural activities of CISV USA.
- B. Scholarship for Humanity, to benefit CISV USA youth who are entering a career which will directly impact the quality of life for humankind.
- C. Scholarship for Ethnic Minority, to assist CISV members (youth and adults) of ethnic decent who would not otherwise be able to afford participation at Chapter, National or International program/activity/workshop. NOTE: This fund is not available for grants at this time.
- D. Ray & Elizabeth Shrader Fund, sole use of Smoky Mountain Chapter

Who can apply for grants?

CISV USA Chapters, Steering Committees, National Committees, juniors and Junior Branches can apply.

What grants can be applied for?

Special projects in line with the purpose of the different sub funds can be applied for.

What is the deadline for grant applications?

Grants are reviewed and accepted all year rounds. Applications decisions are processed by the trustees within 6-8 weeks.

Applicants are encouraged to apply as early as possible, so trustees can review the application and check completeness. For complete, high quality applications, the 2 month time period may not be needed and the decision can be forwarded to the applicant earlier. If funds are not available, the Foundation President will inform the applicant as soon as possible.

Grant Application Details:

Complete the grant application form and attach:

- Short description of the project including planned dates, venue, number of participants
- Budget
- Statement of reference. Projects must have endorsement of the project owner. (i.e. Committee Chair, JB President and/or Advisor, Chapter President)
- Short statement highlighting the benefits of the project (why should this be done).
